




# How it works





#### 1. Gift

Your business can open a Gift Account simply and easily today. Business Accounts start with a minimum \$5,000 donation, are eligible for tax credits and can be named by your business. There is no need to specify upfront what causes you want to donate to, so you can support a variety over time.

#### 2. Grow

For accounts with more than \$20,000, your donations can be responsibly and ethically invested in a variety of ways to grow, tax-free.

#### 3. Grant

Your business can decide when and which charitable causes to donate to, in New Zealand or internationally. The Gift Trust checks their credentials and can provide research or guidance for your business giving.
